• To access reports, select the **Reports** tab.

- E-Subro Hub: Takes users to the new reporting platform for E-Subro Hub reports.
- **Reporting**: Takes users to the reports for Online Filing (OLF) applications.
- **TRS**: Takes users to the new reporting platform for TRS reports.

Note: E-Subro Hub and TRS reporting options are available only to participating members with reporting access privileges.

• The E-Subro Hub option takes users to AF's new visualization reports.



• Clicking on the **E-Subro Hub** option takes users to a report tab screen. From this screen, select **Open Demand Metrics** from the available tabs.

• Currently, the default data will include Open Demands Detail report information as the demander.



- Reports can be filtered by using the following:
 - #1: Company code information is automatically pre-filled based on user login.
 - #2: Users can use the **State** filter for the **Open Demands by Status** chart by selecting one or more states from the drop-down menu.
 - #3: Select this button to run the demand status chart using selected filters.
 - #4: Select this button to refresh the filters and demand status.





• In the top right corner are two additional features.

- Selecting the three dash icon hides the filter options, select the icon again and the filters are displayed.
- The square shaped icon allows users to expand the graphic to full view. Select the icon again to return to the original view.



- A color legend found on the left side depicts the current open demands by status
 - **Denied** demands are indicated in blue
 - Yellow reveals demands In Negotiation
 - **Issued** demands are green
 - Settled demands are denoted in red



• Other status options include: Accepted and Pending.



- The initial visualization graph will show the percentage of demands in the current negotiation status identified by color.
- The center of the graph will show the total open demand count.





• When hovering over a section on the wheel, the color changes and additional information is revealed.



- Users can quickly see that out of the 220 demands, 151 (or 68.64 percent) of demands are in **Issued Status**.
- This action is the same for each of the four sections seen on this wheel graph.
- Clicking on a section versus hovering over it will populate three additional charts on the right side of the page providing additional information based on the status selected.







• The first graph provides additional information on the age of the open demands in issued status. It will show the number of demands in four cycle times ranging from the **Issue** date to the **Current** date.



- Additional details can be reviewed by simply hovering over the column.
- At the top right corner of the screen, users can expand or collapse their view.





• To export data into an Excel spreadsheet, click a specific column. The supporting demand data for the selected column will be exported into an Excel spreadsheet for additional review.

- The next graph provides a count of open demands in **Issued Status**. The details show the count for each **Responding Company**.
- Details will refresh each time a section is selected from the primary wheel graph (as seen on page 11).





- Hovering over the bar for a **Responding Company** will display the count of demands in **Issued Status**.
- Users are able to expand or collapse their view by clicking the icon in the upper right corner.



- Finishing up with the **Open Demands by State** interactive graph, a user can select to zoom in or zoom out using the + and signs on the map graph. When increasing the image, it may disappear from the screen. Simply place the cursor on the screen to drag the image back to center.
- The color of the map and volume of demands corresponds to the heat gauge on the right. The darker the map, the more demand volume.





• This map shows the State of Florida having the most issued demands as seen on the gauge to the right.



• Hovering over the state reveals the total number of demands issued.





• Clicking on the state allows users to export data into an Excel spreadsheet.
